A: SCORING CLINIC

John Santos held a scoring clinic for coaches and representatives that were interested in learning how to score swimming and diving for dual meets.

The host team is responsible for providing: scoring sheets for both teams, lane entry cards for each lane, clipboards and pencils for each lane, a runner to pick up entry cards, backstroke flags at each end of the pool, three sets of diving flash cards, and a P.A. System if possible.

OLD BUSINESS:

John Santos made a motion to change a motion made, seconded and approved at the May meeting (*to move all the relays at the All-Star meet, including the freestyle relays, to the beginning of the meet*). The new motion is to go back to the old set up of having the 8-under free relay, and the 10 & under and 14 & Under medley relays at the beginning of the **All-Star Meet**, and the 12 & Under and 18 & Under Freestyle relays at the end of the same meet. All relays would be swam short course, and the lane-lines will be changed by the staff of Lewisboro to accommodate the 25 yd course. Brenda Lyons (Yorktown) seconded the motion. Long discussion took place afterward. Each club was asked to vote: 20 voted for the new motion, 4 voted against it, 1 abstained. Motion passed.
